Item no. 27 - No software was used to manage the data.

Item no. 28 - Participants did not provide any feedback on the findings.

Item no. 29 – No quotations were presented to elaborated the synthesis speeches through the Collective Subject Discourse method.

Item no. 32 - There was no descriptions of the diverse cases or discussion of minor themes presented.
